


# Evaluate children who have been, or may have been, sexually abused

The **Child Sexual Behavior Inventory (CSBI™)** is a measure of sexual behavior in children ages 2 to 12 years that is completed by the mother or other primary female caregiver. Administration time is 5 to 10 minutes. Available in paper and pencil and for **online administration and scoring via PARiConnect.**

## Assess trauma exposure and symptoms of posttraumatic stress

The **Detailed Assessment of Posttraumatic Stress™ (DAPS™)** is a self-report instrument for adults ages 18 to 91 years that assesses peri- and posttraumatic symptoms and associated features related to a specific traumatic event. It provides a detailed assessment of PTSD with an administration time of 30 minutes. Available in paper and pencil, **online via PARiConnect**, and software.

#### Evaluate the effects of trauma in adults

The **Trauma Symptom Inventory**<sup>™</sup>-2 (**TSI-2**<sup>™</sup>) is a broadband measure designed to evaluate posttraumatic stress and other psychological sequelae of traumatic events in adults ages 18 to 88 years, including effects of combat, physical abuse, and childhood abuse or neglect. Administration time is 20 minutes. Available in paper and pencil, **online via PARiConnect**, and software. The **TSI-2-A** is an alternate form that does not contain any sexual symptom items.


## Quickly evaluate effects of trauma in children

The Trauma Symptom Checklist for Children™ (TSCC™) allows you to measure stress and related psychological symptomatology in children ages 8 to 16 years who have experienced traumatic events. Administration time is 20 minutes. Available in paper and pencil, online via PARiConnect, and software. The TSCC Screening Form (TSCC™-SF) is also available, takes just 5 minutes to administer, and is available in paper and pencil or via PARiConnect. The TSCC-A is an alternate form that makes no reference to sexual issues.
